



Naples Youth Soccer Club 2011-2012 Payment Plan Policy

Registration Fee:

The registration fees for the 2011-2012 season are:

1. \$675 for State Cup team players
2. \$499 for Region Cup team players, U11 and up
3. \$399 for Academy team players U10 and under

If you are uncertain of whether your team is classified as an Academy, Region or State Cup team, please visit the coach's link at www.naplessoccer.com or contact Gavin Spooner or Angelika Dean. All outstanding player registration fees for the prior seasons must be paid in full before a player can register for the 2011-2012 season.

Uniform Fee:

The uniform fee for the 2010-2012 Season's is **\$115**. This fee is in addition to the registration fee noted above. Only new players need to purchase the uniform. The fee **must be paid in full** at the time of registration.

Registration Discounts and Payments:

- 1) We offer an **early bird discount of \$25 per player** if the fee is paid in full at the time of the initial registration (Prior to June 30, 2011).
- 2) We offer a registration **discount for siblings of \$25 for each 2nd, 3rd**, etc child.
- 3) We welcome you to **pay** using **credit cards** (Visa/Mastercard/Discover)

Registration Payment Plans:

- 1) Registration fees may be paid via a payment plan to be made in 3 equal installments:
 - 1/3 Due at Registration
 - 2/3 Due no later than **July 31, 2011**
 - Final Balance due no later than **August 31, 2011**
 - a. State Cup \$255 / \$210 / \$210
 - b. Region Cup U11 + \$199 / \$150 / \$150
 - c. Academy U10 – \$133 / \$133 / \$133
- 2) All payment plans require a signed Payment Plan Agreement which must be approved by either the Finance Committee, Registrar or DOC;
- 3) All payments must be paid in full prior to the distribution of the player pass. If a player pass is needed prior to the August 31, 2011 final payment date, this final payment must be made prior to the release of the player pass or an extended payment plan must be authorized.
- 4) Extended payment plans past **August 31, 2011** must be authorized by President or DOC and may be subject to a 10% payment plan extension fee.
- 5) For financial aid applications, the payment plan will follow # 1 based upon the awarded fee. All applications will be reviewed and approved / declined within 30 days, if declined the remaining balance will become due and repaid over the remaining term of the payment plan.
- 6) Player's who take advantage of the payment plan will be notified of the consequences of non-payment at the time of registration by execution of the payment plan agreement.
- 7) In addition, by signing below, you agree to pay all debt recovery costs, small claims court fees and returned check fees Naples Youth Soccer may incur in the collection of these fees.
