



Naples Youth Soccer Club 2008-2009 Payment Plan Policy

Registration Fee:

The Registration Fees for the 2008-2009 Season are:

1. \$625 for State Cup team players
2. \$475 for Region Cup team players, U11 & Above
3. \$425 for Region Cup team players U10 & Under

If you are uncertain of whether your team is classified as a Region Cup or State Cup team, please visit the coach's link at naplessoccer.com or contact Gavin Spooner or Angelika Dean. All outstanding player fee payments for the 2007-2008 or before season must be paid in full before a player can register for the 2008-2009 season.

Uniform Fee:

The Uniform Fee for the 2008-2009 Season is **\$100** (in addition to Registration Fee for players purchasing a full new Uniform Kit) for all new players. Existing players will enter the 2nd year with the current uniform. The Uniform Fee must be paid in full at the time of registration. Additional or replacement items for existing players may be ordered at registration.

Registration Discounts and Payments:

- 1) We offer an **early bird discount of \$25 per player** if the fee is paid in full at the time of registration.
- 2) We offer a registration **discount for siblings of \$25 for each 2nd, 3rd**, etc child.
- 3) We welcome you to **pay** using **credit cards** (Visa/Mastercard)

Registration Payment Plans:

- 1) Registration Fees may be paid via a Payment Plan to be made in 3 equal installments:
 - 1/3 Due at Registration
 - 2/3 Due no later than **August 29, 2008**
 - Final Balance due no later than **September 26, 2008**
 - a. State Cup \$215 / \$205 / \$205
 - b. Region Cup U11 + \$165 / \$155 / \$155
 - c. Region Cup U10 – \$145 / \$140 / \$140
- 2) All payment plans require a signed Payment Plan Agreement which must be approved by either Paul Kindred, Angelika Dean or Gavin Spooner
- 3) Payment plans extended through **September 26th** must be solely authorized by Paul Kindred and maybe subject to a 10% payment plan extension.
- 4) If the Final Payment due under a Payment Plan is not made within 30 days of the final due date, the player's pass will be pulled and can only be reinstated upon receipt of payment in full.
- 5) For scholarship applications, the payment plan will follow # 1 based upon the scholarship fee. All applications will be reviewed and approved / declined within 30 days, if declined the remaining balance will become due and repaid over the remaining term of the payment plan.
- 6) Player's who take advantage of the payment plan will be notified of the consequences of non-payment at the time of registration by execution of the Payment Plan Agreement.
- 7) Team managers will be notified of players on payment plans and unpaid balances 09/26, indicating those players potentially at risk for passes pulled.
- 8) In addition, by signing below, you agree to pay all debt recovery costs, small claims court fees and returned check fees Naples Youth Soccer may incur in the collection of these fees.
